RESOLUTION NO. R –10 – 18- 55

A RESOLUTION REPEALING RESOLUTION NO. R-08-18-45 ADOPTED BY COUNCIL ON AUGUST 16, 2018 AND FURTHER AUTHORIZING THE CITY MANAGER TO ACCEPT PROPOSAL OF AND ENTER INTO AN AGREEMENT WITH ACE INDOOR GOLF, LTD FOR THE PURCHASE AND INSTALLATION OF TWO GOLF SIMULATORS FOR USE AT MEADOWBROOK AT CLAYTON AT A TOTAL COST NOT TO EXCEED \$81,900.00

WHEREAS, on August 16, 2018, Council authorized the City Manager to enter into an agreement with Ace Indoor Golf, LTD for the rental of two indoor golf simulators for use at Meadowbrook at Clayton; and

WHEREAS, further review of the rental of golf simulators as compared to purchase of golf simulators resulted in the City issuing a request for proposals to better determine the economic feasibility of a possible purchase of golf simulators; and

WHEREAS, per Clayton Charter Section 8.02(B), requests for proposals were solicited for the purchase and installation of two golf simulators; and

WHEREAS, as a result of the request for proposals, City Staff received and reviewed four proposals for the purchase and installation of two golf simulators and Staff recommends the City repeal Resolution No. R-08-18-45 and accept the proposal submitted by Ace Indoor Golf, LTD as being the lowest and best responsive bid submitted by a responsible bidder for the purchase and installation of two golf simulators at Meadowbrook at Clayton at a total cost not to exceed \$81,900.00.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLAYTON, STATE OF OHIO:

1. That Resolution No. R-08-18-45 is hereby repealed and the City Manager is authorized to accept the proposal submitted by Ace Indoor Golf, LTD as being the lowest and best responsive bid submitted by a responsible bidder for the purchase and installation of two golf simulators at Meadowbrook at Clayton at a total cost not to exceed \$81,900.00.
